

NEW EMISSION REGULATION FOR BS-VI COMPLIANCE VEHICLE

“Central Motor Vehicle Rules 1989, Automotive Industry Standard-137 Part – 3rd of standard (Regulation)” applicable for all BSVI vehicles sold after 1st April 2020, makes it mandatory for all Car manufacturers in India to check emission parameters.

New Regularity Check Requirement

For regularity check requirement, “Honda Car India Ltd” would request all the customers of eligible vehicles for their consent for providing their vehicle for below mentioned regularity item check:

- Verification of pollutant levels of exhaust gas (ISC)
- Retrieving the emission control related system/component data captured inside vehicle Engine Control Unit (ECU) during the usage (IUPR)



Vehicle Selection Criteria

From date of sale

← 6 months or 15,000 kms



→ 5 years or 100,000 kms

“HONDA” customer care will contact customers if their Vehicle is identified for ISC/IUPR testing by the test agency .

FAQs

FREQUENTLY ASKED QUESTIONS

Why is this testing (ISC or IUPR) required?

This is a compliance testing vide CMVR regulation as implemented by Government of India (“GOI”) wef 1st April 2020.

What does In-Service Compliance(ISC) or In-Use Performance Ratio(IUPR) mean?

In-Service Compliance (ISC) or In-Use Performance Ratio (IUPR) means complying to the emission norms as laid down by the Ministry of Road Transport & Highways (MoRTH) for the vehicles currently In-use/service.

Why is my car being selected for the ISC or IUPR test?

Selection of car for testing will be carried out on the basis of Customer Vehicle Service History and usage pattern.

How do I know if my vehicle is eligible for testing?

All BS VI vehicles manufactured from 1st April 2020 are eligible. Govt. approved testing agency will identify and select vehicles from the market. Customers will get the information through Honda Dealers if their Vehicle is identified for testing.

What type of testing will be done in my vehicle?

For ISC, Mass Emission test is conducted & For IUPR, OBD (On-Board Diagnostic) data will be retrieved from ECU.

Note:- No repair/replacement/opening of any part.

For how much duration (Days) for ISC & IUPR, customers have to spare their vehicle for testing?

For ISC, Vehicle testing duration may vary between 15 to 30 days & for IUPR, may vary between 1 to 2 days, subject to location and other conditions. Any further details will be shared by the concerned dealer.

Will I be charged for testing?

No, the testing process will be free of cost to the customers.

Will there be any negative impact in performance on my vehicle post testing?

No, there will not be any impact on performance of the vehicle.
