## HCIL expands its campaign to replace Takata Driver and Passenger Front Airbag inflators in India

**New Delhi, 29 July 2019:** Honda Cars India Ltd (HCIL) today announced that it has expanded its campaign to replace Takata driver and passenger front airbag inflators in 5,088 units of its previous generation models of Jazz, City, CR-V, Civic and Accord as part of Honda's precautionary global recall campaign concerning Takata front airbag inflators.
